CERTIFICATE CONDITIONS

- 1. This special certificate is being offered by DMG MORI and Hartmetall-Werkzeugfabrik Paul Horn GmbH. It exclusively benefits business partners of DMG MORI that are either based in the Federal Republic of Germany or have production facilities there.
- 2. Every business partner that orders and obtains a new machine from DMG MORI is entitled to participate in this special certificate offer. The business partner may request to receive the Horn certificate from DMG MORI; this will then entitle it to obtain products for the new machine it has ordered up to the value of the certificate. Products can be obtained from the standard range of Hartmetall-Werkzeugfabrik Paul Horn GmbH, Tübingen, minus a 15% certificate discount and plus the statutory VAT that applies in each case. The relevant Horn list prices apply in each case. Once DMG MORI has transferred the business partner's required data to Horn (customer name, contact person, machine model, expected delivery date, etc.), the business partner shall gain direct access to Horn's selection of products. The business partner explicitly agrees to having these data transferred. The business partner shall inform DMG MORI of the products it has chosen from Horn. DMG MORI shall
 - send the appropriate order to Horn; this shall be completed in a timely manner so that the products selected by the business partner can be delivered at the latest two weeks before the new DMG MORI machine arrives.
- 3. In return for the products due to be delivered by Horn, the business partner shall make payments exclusively to DMG MORI. If the value of the order exceeds the value of the certificate, the business partner shall also pay DMG MORI the excess amount not covered by the certificate so that this amount can be passed on to Horn.
 - If the order value is less than the certificate value, the difference is not paid out or credited. Instead, this amount is forfeited.
 - The products ordered shall be delivered free of charge to the business partner, but not if the delivery is outside the Federal Republic of Germany.
- 4. The Horn certificate may only be used for Horn products in conjunction with a new DMG MORI machine and only in a single transaction: the value may not be partially redeemed.
 - The Horn certificate may not be redeemed together with other discounts and/or price agreements. The certificate may not be exchanged for its monetary value.
 - The Horn certificate must be redeemed within 12 months of the issue date. It may only be redeemed by the business partner named on it and is not transferable.
